## About Course

The "Election Security and Violence Mitigation" course is designed for election officials, security personnel, community leaders, and everyday citizens who wish to contribute to safer, more peaceful elections. Participants will learn to identify early warning signs of conflict, understand the sources of electoral violence, and apply practical strategies for de-escalation and risk reduction before, during, and after voting activities.

## Course Overview

Electoral violence undermines democracy, destabilizes communities, and discourages civic participation. This course provides essential knowledge and field-tested techniques to minimize tension, ensure the safety of voters and officials, and promote trust in the electoral process. The course uses real-world case studies, simulations, and group discussions to build practical skills.

Designed for accessibility, it requires no prior background in security or elections—only a willingness to learn and collaborate. The focus is on grassroots-level solutions and inter-agency cooperation, helping all stakeholders contribute to a more secure democratic environment.

Participants will explore the role of community dialogue, emergency preparedness, communication strategies, and legal frameworks in deterring violence and preserving electoral integrity. The course encourages both preventive planning and responsive coordination.

## Course Objectives

The objective of this course is to equip participants with the knowledge and tools to support peaceful and secure elections by recognizing potential threats, coordinating with others, and applying early interventions that reduce the risk of violence.

- Understand the causes and patterns of electoral violence
- Learn risk assessment methods before and during elections
- Coordinate between stakeholders to ensure election safety
- Apply community-based strategies for de-escalation and trust building
- Participate in scenario-based simulations for practical experience
- Strengthen communication protocols for rapid response and awareness

- Promote civic education and peaceful participation at all levels

## Learning Outcomes

- Assess key indicators of potential election-related violence
- Implement mitigation strategies to reduce risk and tension
- Coordinate effectively across roles: civic, security, and election officials
- Develop a localized safety plan with community engagement
- Promote voter confidence and public awareness around peaceful participation
